COMMUNITY-BASED MENTORING - OUR COMMUNITY-BASED MENTORING PROGRAM TAKES PLACE IN-PERSON, WITH BIGS AND LITTLES MEETING TOGETHER 2-4 TIMES A MONTH. WHETHER A MATCH IS GRABBING ICE CREAM, TAKING A WALK, HITTING UP THE LIBRARY, OR ATTENDING A BADGER GAME, THE GOAL IS TO PRODUCE QUALITY TIME THAT BUILDS A STRONG AND TRUSTING RELATIONSHIP. IN 2023, 440 YOUTH WERE MATCHED WITH A CARING ADULT MENTOR.

IN THE FALL OF 2023, WE EXPANDED AND ENHANCED OUR TWO SCHOOL-BASED MENTORING PROGRAMS (SCHOOL FRIENDS AND HIGH SCHOOL LEADERSHIP PROGRAM) TO DRIVE EDUCATIONAL AND SOCIAL-EMOTIONAL OUTCOMES FOR 50-60 YOUTH IN ELEMENTARY, MIDDLE, AND HIGH SCHOOL.

THE HIGH SCHOOL LEADERSHIP PROGRAM (HSLP) IS AN ENHANCED VERSION OF SCHOOL FRIENDS. IN PARTNERSHIP WITH WEST HIGH SCHOOL AND RANDALL ELEMENTARY, THIS INNOVATIVE PROGRAM PAIRS HIGH SCHOOL MENTORS WITH ELEMENTARY MENTEES IN MENTORING RELATIONSHIPS THAT BUILD CONFIDENCE AND INCREASE CONNECTEDNESS TO SCHOOL, CULTURE, AND PEERS. THE PROGRAM USES A CURRICULUM THAT GIVES YOUNGER AND OLDER STUDENTS AN OPPORTUNITY TO GROW AND LEARN FROM ONE ANOTHER DURING THEIR WEEKLY MENTORING SESSIONS, WITH ENGAGING ACTIVITIES CENTERED ON TOPICS LIKE DEVELOPING A GROWTH MINDSET, BUILDING EMPATHY, LEARNING STEM SKILLS, AND PRACTICING GRATITUDE. HIGH SCHOOL MENTORS ALSO RECEIVE COACHING AND MENTORSHIP FROM BBBS STAFF.

OUR PROGRAMS DO NOT DIRECTLY PROVIDE ACADEMIC SUPPORT, BUT RATHER IMPACT ESSENTIAL ELEMENTS OF YOUTH DEVELOPMENT, REDUCING EDUCATIONAL
